The European Lawyers' Union (UAE) has chosen the Island of Malta for its Annual General Assembly and for the conference on Competition Law because of the island's particularity and strength, which derives from the extraordinary and strategic position as the crossroads of the Mediterranean that served as the link between Europe and Africa. Today, the Island serves as a privileged tourist attraction because of its numerous and amazing archaeological and historical-artistic sites: from the megaliths, to the Cammino di San Paolo, to the fortifications of the Knights of Malta, to the baroque churches.
