## **Who we are**

The UAE - European Lawyers' Union brings together the practicing lawyers within the European Union. Founded in Luxembourg in 1986, the UAE is celebrating its thirtieth anniversary this year.

The UAE is structured in regional and national delegations and in commissions specialised in a given area of law. The delegations and commissions regularly organise conferences and seminars and play a significant role in the life of national and regional communities. The association promotes the publication of the most relevant contributions to its events, and intervenes on matters of common concern for the practice and the rule of law in Europe.

The annual Congress is the main scientific event of each year, usually hosting a varied faculty of practitioners, academics and researchers, representatives of the EU and national institutions and members of the business community, around a theme of topical interest. The General Assembly, usually held in the last months of each year, is also an important part of the associations' year, and usually includes both a scientific and an institutional component. This thirtieth anniversary year will be commemorated in a meeting with the Court of Justice of the European Union, which will follow the General Assembly.

The proceedings of many annual congresses and other relevant conferences have been published in the UAE Collection, a joint project of the UAE and the editing house Bruylant (presently part of the Larcier Group).
